 - 6.1. School Safety Plan Report by Ruben Nolasco, Safety and Facilities Operations Manager: Mr. Nolasco will conduct a presentation that highlights components of the plan. Recommendations from the REACH SSC are welcome. The final draft of the plan will be approved by the REACH Governing Board before the March 1st deadline.

Comments and Notes: 4 monthly drills (cohort A and B) - Fire Drill and Emergency Drill Lock down, Code red, and more. Murillo asked how drills are messaged to students. Nolasco explained that protocols are released to teachers who disseminate information to students and follow protocol. Sanchez and Hokanson praised Mr. Nolasco's organization with drills

6.2. School Climate Surveys: The School Site Council will discuss the questions that the administration recommends for the next school climate survey that will go to parents. Comments and Notes:

-Cairney questioned if we can add more questions on specific health safety in regards to COVID and being on campus.

-Hokanson brought up to be specific to the actual school and not feelings of safety. Is it the right place to ask if we can figure out a way of what parents need. Since all students are not at school, we have less access.

-Murillo recommends to ask if school is taking the appropriate measures -Cairney suggests if there are suggested measures. Expand the socio-economic or emotional part of the survey to understand the needs of families.
