Comments and Notes: Genevieve suggested certain positions should have a longer-term, with the third year being in a supportive and training role. If re-elected, would the term start over? Delfino suggested that at least half of the members should step down, with the possibility to run again, so that we can have alternating elections. Genevieve suggested that, regarding the certificated seats, we alternate so that one year two teachers are elected, and the next year the third teacher runs. She also was wondering if someone was re-elected, would their term start over? Jenn Grob said she would be willing to re-run again this year. Hokanson volunteers to run again. Grob agrees, Murillo was questioned in the third year or three months as a transitional period. How many officer positions are there? Chair, vice-chair, and secretary. Jennifer Hamilton asked about the timing for a 2-year term. Hokanson suggested that Murillo, Hokanson, and Sanchez would run again next year and if we don't win, we help train for the next position. Murillo does not think we should re-run this year since we are so new. Hokanson feels the chair position is most crucial to keep in place at least one more year to solidify the SSC. Murillo fully believes and supports the mission statement and to create a better future. We are still getting used to our positions and figuring out what the future holds. Findlay recommended we list out questions for next time.
