## 5.1. Director's Report

#### Comments and Notes:

- School has secured a line of credit with Charter Asset Management (CAM) for \$1.2 million which will all charter to phase out receivable sales by May 2020.
- CAM discounted 5k legal fee to 1k.
- School will save approx. \$30k per year in receivable sales fees by going this
  route.
- School will remain closed from March 16 through April 30.
- Enrichment packets were sent home with students on March 13.
- Teachers in grades 3-6 will begin distance learning on Wednesday, March 16.
- Essential staff will continue to provide office assistance and distribute food to families during the closure.
- All non-essential workers will be released tomorrow.
- Chromebooks are being checked out to 3-6 grade students.
- Currently, in grades TK-2, students are provided enrichment activities including some online learning.
- Teachers will hold office hours daily. Lower grade teachers (TK-2) will check-in with all families weekly.
