7.1. Director's Report

- Line of Credit (LOC)
  - LOC matures in March.
  - REACH has chosen not to renew the LOC at this time.
  - Exploring next steps.
  - Do not anticipate a cash need for the remainder of the school year.
- Enrollment Updates
  - Current Enrollment <u>631</u>
  - Will be lowering our forecast for the remainder of the school year based on current trends.
  - Next month's budget will show lower enrollment/ADA and financial impact.
  - Due to additional one-time funding, school does not anticipate a negative financial impact on EOY fund balance.
- Facility Update
  - Conditional Use Permit (CUP)
    - CUP Expires June 2022
    - Met with RUSD to discuss our request for exemption pursuant to Government Code Section 53090-53097.3 which grants the rights to charge schools to make a written request to render city ordinances inapplicable.
    - REACH responded with a formal letter and supporting documents
    - Awaiting response from RUSD to see when matter will be brought before the board.
    - Also working with the City of Riverside with regards to requirements to modify current CUP.
    - Background
      - Public schools are automatically exempt from such ordinances.
      - Charter schools must request exemption status
      - REACH has been granted an exemption twice in the past
      - Exemption does not absolve the school of California Building Standards, but it will address the temporary status of our CUP
      - Currently the school has to address a CUP which expires every couple of years.
      - The city is requesting that the school make the modular buildings permanent



- School is not in a position to move or make changes to the facility
- We are exercising our rights as a public school to be exempt
- Concurrently, we are meeting with the City of Riverside next week to address our status.
- <u>New Playground Equipment</u>
  - <u>New Play Structures</u>
    - Original plans included playground structures on both kindergarten and the main playground
    - Began installation on 1/17/21
    - Structures are DSA approved
    - Construction has been halted pending permits
    - Submitted application
    - Cleared planning, building & safety, now waiting for contractors to pull permits and complete the work.
    - New lunch benches have been installed
    - New shade structure over lunch area to be purchased
      - In the process of ordering
      - Will also require city approval
      - Being told materials will take a while to receive
      - Planning to place order this month
      - Communication with contractors has been slow
- <u>School Closure</u>
  - School was closed 1/3/22 thru 1/11/22
  - Approximately 13 staff, including teachers, nutrition and PE were out due to COVID
  - Operations were impacted
  - School will close the first week as no attendance days since the independent studies policy was not in place.
  - ADA will not be affected.
  - No need to extend the school year
  - State requisite attendance days are 175. REACH has 183 days of attendance.
  - Closed campus for a little over a week
  - School reopened in a day with little notice
  - Lack of clarity re: how long school could remain closed once staff began to return to work
  - Subsequently sent notice to families that school closures due to staff shortage could happen again in the future
  - Updated Independent Studies (IS) policy to reflect state guidelines regarding distance learning beyond 14 days requires board approval
  - New guidelines include synchronous instruction as well as additional IS protocols referenced below.



- Today's Board Meeting
  - SARC
    - Update Every Year in January.
    - Deadline Feb 1
    - This year's academic data includes local assessments. In this case the STAR that Mr. Findlay presented in December.
    - Student data has been disaggregated by demographics and included in the SARC report.
    - The SARC report is intended to give the public access to all California public school data and information via an online portal.
    - Leads to better transparency and increased accountability
- Teacher Salary Schedule
  - Step and Ladder teachers salary table
  - Salaries are commensurate with surrounding school districts (CNUSD, RUSD, JUSD, AUSD)
  - In the past, REACH gave annual COLA increases
  - Salary schedule is more in-line with other schools and districts
- <u>Academic Update</u>
  - Students take DIBELS & STAR assessments in Feb/Mar
  - Comparison data will be shared once assessments are complete
  - SBAC assessments begin in May
  - Teachers in grades 3-6 are starting to ramp up test prep in anticipation of the SBAC assessments
  - More info to follow
  - Action Items:
    - Independent Studies (IS)
      - Amended document addresses instruction in the event of emergency school closure
      - The amended policy allows for synchronous instruction and extends the 14-day timeline otherwise allotted for IS.
      - The new provisions do not apply to or change general provisions of IS under normal circumstances. It only applies to emergency closures where synchronous instruction is taking place
      - Policy includes an extensive plan for parent outreach in the event of non-engagement.
      - IS is voluntary.
    - Vote for Secretary
      - We did not have any board members volunteer to run for the open board seat.
      - We have asked Jennifer Boren to run again for the position.
      - Jen has been on the REACH school board since the school's inception.
      - She is a part of the founding team and has served as board secretary on and off for the past 9 years.



- We appreciate her many years of service and are pleased that she is willing to continue to serve in this capacity.
- We recommend that the board approve this nomination.

9.5. LCAP Supplemental: It is recommended that the RSLA School Board approve the 2021-2022 LCAP Supplemental Plan.
