8.1. **Instructional Minutes 2021-22**: It is recommended that the REACH LSA governing board approve updates to the Instructional Minutes for the 2021-22 school year. #### 8.2. Unaudited Actuals Report 2020-21:

For the period July 1, 2020 to June 30, 2021, the submission of charter school financial data to the California Department of Education (CDE) is required by <u>Education Code</u> <u>Section 1628</u> and by <u>Education Code Section 42100</u> (as amended by Assembly Bill 1994). Charter schools must submit the completed forms to their authorizing agencies



by September 15, 2021. <u>Unaudited actuals are financial data that is pending final</u> **audit.** The authorizing agencies will submit the forms to their county offices of education, who will submit the forms to the CDE by October 15, 2021.

The Unaudited Actual report was presented during the August 23, 2021 board meeting under item 6.2, Financial Report by Edtec (Report: <u>REACH - FY21 UAR & FY22 Budget</u> <u>8.17.21</u>). To remain in compliance, the Unaudited Actuals Report 2020-21 requires separate board approval. It is recommended that the governing board approve the Unaudited Actuals for the 20-21 fiscal year.

8.3. New Master Lease Agreement with InSight Investments, LLC ("InSight"):

The Master Lease Agreement between InSight Investments and REACH outlines terms, schedules, and conditions related to the modular units that are currently being leased by REACH. SKC, the previous owners of the modular units, transferred ownership to the new lessor, InSight Investments in August 2021. In the course of the transaction, \$200,000.00 was added to the overall lease amount to be used for playground and site improvements. The additional \$200,000 was added at no interest. The additional \$200k will be paid in full over the course of a 5 year period. The increase in the lease amount through August 2026 is a difference of \$3333.00 per month over the next 5 years.
