- <u>9.1</u> School Accountability Report Card (SARC)
  - Board reviews Annually
  - Report Card for every public school in the State of California
  - Outlines the condition and performance of each school
  - Always a year in review
  - SARC provides parents with vital information about the overall performance of the school their child attends.
  - Allows for easy comparison.
  - Includes demographic information, teacher qualifications, textbook sufficiency, condition of facilities, school safety, academic performance.
  - Requires board approval.
  - 9.2 Updated Teacher Salary Schedule 2023-24
    - We recommend that the board approve the updated salary schedule for teachers
    - The salary schedule is the same as the one submitted for approval last year, with the exception of the final column which gave an additional pay increase for teachers with a BA + 75 units.
    - No other changes have been made.
    - With the new COLA increase, the school will look at the possibility of updating the salary schedule to reflect additional increases where feasible with a longer-term view at overall sustainability.
- <u>9.3</u> Audit Engagement Letter
  - The LEA is required to have on file an updated agreement between the auditor and organization.
  - Assures that the school stakeholders understand the terms and objectives behind our engagement and the nature of services that the audit firm provides including its responsibilities as well as limitations.
  - Bakertilly will perform this year's audit ending June 30, 2023.



- The school will need to make another audit selection for the 2023-24 school year.
- LEA's must make a new auditor selection every 1-3 years.

  - Amendment to the Articles of Incorporation is related to the school's desire to operate two sites.
  - Attorneys recommended changes to our statement of purpose to include operating one or more Calif. Public charter schools.
- <u>9.5 9.6</u> Non public Agencies
  - Master Contracts for the purpose of providing specialized services to our special needs students who carry IEPs (Individualized Education Plans).
  - Services can include but are not limited to: assessments, records review, screenings, IEP attendance, academic testing, speech evaluations, etc.
  - Shortage of providers.
