- Need to remove an RUSD reference that we did not catch (SPED services are no longer under RUSD)
- District stated it could not locate our Universal Complaint Procedures. Item was located on our website. We provided the link. But it still showed up in the report.
- District stated that the financials were incomplete. We completed the financials that we have always submitted for a renewal hearing. Furthermore, according to the statute for high-performing charters: "A charter that satisfies the [high-performing] criteria in subparagraph (A) or (B) shall only be required to update the petition to include a reasonably comprehensive description of any new requirement of charter schools enacted into law after the charter was originally granted or last renewed and as necessary to reflect the current program offered by the charter."
- The one item that could be considered a "finding" possibly is the Item 6, admission preferences. Based on incorrect information, we removed the reference to giving RUSD students preference in the lottery. Preference was given to Highland Elementary School (in district) but not to all RUSD schools. According to Education Code section 47605(e)(2)(b), preference shall be given to students currently attending the charter school and to pupils who reside in the school district..."
- REACH will address this error in the petition.
- REACH crafted response to the District which I will share with REACH Board tomorrow.
- Final outcome:
 - Recommending 5 year renewal
 - School has 1 year to update petition
 - If deemed appropriate, the district may grant an additional 2 years
- School contends that the requests are benign and can provide those items now as we have already demonstrated our ability to do so.
- No need trouble the RUSD board with another hearing for an additional 2 years
- District mentioned it needs to update its policies per the statute and will do so this July.
- Stated that it does not have the ability to go beyond 5 years currently.
