- Enrollment Updates
 - Enrollment is currently under projections
 - o 5th & 6th grades are under enrolled by approx. 17 students.
 - 9 enrollment packets pending
 - 1 in 5th/6th grade
- Facility Update
 - Plans for middle school are underway
 - Projected timeline- August 2024
 - Will serve grades 5-8
 - Focus on STEAM
 - Facility is projected to include

- Full gymnasium
- Science lab
- Library and media room
- All modular buildings
- · Facility and buildings all leased
- Ultimate vision is to purchase land and build K-8 facility
- Plans to enlarge two 1st grade classrooms are in the works
 - Will not increase capacity
 - Will allow space for small, physical library
- 2022 Smarter Balanced Assessment (SBAC) Results
 - Growth in nearly all grade levels when comparing 2019 and 2022 data in both ELA and Mathematics
 - Decline in scores in 3rd grade which could be attributed to learning loss due to COVID19
 - Outperformed the district in all grade levels including 3rd grade.
 - Particularly proud of 5th grade science scores on the CAST which performed at nearly 60 percent proficiency rate.
 - o State data has not been released.
 - African American student achievement
 - Showed growth in ELA in nearly every grade level
 - Achievement in both ELA & Math outpaced the school district
 - (State data not available)
 - Chief concern is African American test scores in Mathematics which declined in nearly every grade level when comparing 2019 and 2022 test scores.
 - Will have AAPAC officers present data at the next board meeting on AA achievement data and vision for closing achievement gap for this particular student group, particularly in Mathematics.

Staffing Update

- Special Education Director
 - Last day November 30
 - Will replace with Program Directors I & II
 - Program Director I role is potentially filled
- Other Vacancies
 - 5th grade ELA (LT credentialed sub)
 - 5th grade Science teacher
 - Had to step away from the classroom, temporarily.
 - Can only hold the position open for a couple of months.
 - Position currently filled with LT sub.
 - Speech Pathologist

Finances

- School is in excellent financial position
- An additional \$1M expected over the next few years (not reflected in the budget)

- Ended last year within budget. The only changes were due to some auditing preferences in terms of when to apply a particular funding source. Amita will explain in the pre-recorded financial presentation.
- Expected to end this year within budget.
- LEA is in such a strong financial position that ESSER funds have been pushed into out years.
- o Can pull down ESSER funds into this year if needed.
- In addition to day-to-day operations, additional funds are allocated towards LCAP priority goals in the following manner:
 - Teacher supports in the form of math and ELA coaches
 - Interventionists to support struggling learners at every grade level
 - TK aids in each TK classroom (required)
 - Residential substitutes
 - Professional development for all instructional staff, administrators, and classified staff.
 - AAPAC stipends for teachers
 - ELPAC Coordinator
 - Hiring of new Intervention coordinator
 - Expansion of the 1st grade classrooms
 - Expanding into middle school
 - Resource room manned by FTE credentialed teacher
 - Focus on 4-6 graders who are not reading at grade level
 - Use Read 180 and System 44 program
 - Only focus is on ensuring every scholar is reading at grade level before promoting to middle school.
