- Expanded Learning Program Plan (ELO-P)
  - Schools required by EC Section 46120(b)(2) to create an expanded learning program. Program includes:
    - 30 additional expanded learning days on to the school year
    - Schools must provide 9 hours learning and hands-on opportunities per instructional day
    - Program must be open to all students free of charge
  - Plan Guide below describes program activities that support the whole child including social and emotional learning and development
  - Expanded learning days include: before school, after school, summer and/or intersession days

7.2. Extended Learning Opportunity Plan (ELO-P): ELO-P provides funding for after-school, summer enrichment programs, as well as intersession days for Transitional Kindergarten through 6th grade. The program is intended to provide more interactive, hands-on learning opportunities for scholars beyond the normal school day. Programs are intended to be data-driven, results-focused, pupil-centered opportunities that include community partners. It is the intent that said programs do not replicate regular learning activities throughout the school year but enhance them. As outlined in its report, RLSA shall extend its calendar year to include: 3 intersession days throughout the school year, 3 additional hours daily by partnering with the BRIDGE program to provide after-school care (already in effect), as well as an additional 27 days in the summer and throughout the year, including providing summer school and sports academy to all scholars. Enrollment preferences shall be given to scholars who qualify for Free and Reduced Price Lunch.

It is recommended that the RLSA School Board approve the Extended Learning Opportunity Program Plan in order to comply with EC Section 476120(b)(1)(B) which dictates that 30 non-school days and no less than nine-hours of in-person expanded learning opportunities per day be added to the educational program. LEAs are

encouraged to collaborate with community-based organizations and childcare providers to maximize the number of expanded learning opportunities offered.
